1. Introduction and Purpose

This Data Sharing Agreement (the “Agreement”) governs the collection and use of data submitted through our Wild Cooperative Onboarding form.

By ticking the consent box and submitting data, you (“the Submitter”) confirm that you have read, understood, and agree to the terms below.

2. Data Submitted

Data submitted through our forms may include **General Data** such as:

- General information such as names, organisational affiliations
- Responses to survey or questionnaire fields
- Opinions, feedback, or qualitative data provided in open text fields
- Documents or files uploaded as part of a submission

Data submitted through our forms may also include **Personal Contact Details** (separate from General Data) such as:

- Contact details, including email addresses, phone numbers, and postal addresses (see Section 4)

Data submissions and removal requests may take up to three calendar months to complete.

3. Grant of Rights for General Data

By submitting data through our forms, you grant us a **worldwide, royalty-free, perpetual, and unrestricted licence** to use, reproduce, adapt, publish, translate, distribute, and otherwise exploit the submitted data for any purpose, including but not limited to:

- Research, analysis, and reporting
- Development and improvement of products, services, and processes
- Commercial, promotional, and marketing activities
- Sharing with third-party partners, affiliates, or service providers
- Training machine learning models or other artificial intelligence systems
- Creating derivative works or datasets
- Any other lawful purpose at our sole discretion

You waive any right to compensation, approval, or attribution in connection with our use of the submitted data, unless otherwise agreed in writing.

You retain the right to remove your data for any reason and at any time. To do so contact us using the details in Section 10.

4. Protected Rights for Personal Contact Details

Personal contact details means:

- Individual's Name
- Email addresses
- Telephone and mobile numbers
- Postal and residential addresses
- Any other information that could be used to directly contact the individual

Personal contact details will be collected, stored, and processed strictly in accordance with our **Privacy Policy** available [here](#). We will not use personal contact details for any purpose beyond those specified in our Privacy Policy without obtaining your separate, explicit consent.

5. Your Warranties

By submitting data, you warrant and represent that:

This Agreement is governed by the laws of the United Kingdom. Any disputes shall be subject to the exclusive jurisdiction of the courts of the United Kingdom.
